As inducement to you, Inertia Tours to rent a unit to my group and myself, we unconditionally guarantee payment for all charges to my (our) unit including (but not limited to) damage, lost items, damaged or missing furnishings, excessive cleaning, lost rentals due to my unit needing repairs, etc..beyond your damage coverage protection. Also, we agree to pay for reasonable attorneys fees and court costs if necessary to collect under this agreement and agree to waive all chargeback rights on my (our) credit cards to Mazatlan Express & Inertia Tours

**YOU MUST PROVIDE (2) CREDIT CARDS PER GROUP with photo copies front & back of these cards, as well as a signed Credit Card Authorization to Bill form completely filled out (on back), regardless of if they have been previously submitted**

Further, we agree to uphold the following “house” and/or tour rules AND the terms & conditions:

- 1.) No partying in condos. Excessive noise after 11 p.m. will result in your immediate eviction, and there are no refunds for evictions of any type. This serves as your one and only warning. We have parties set up for good reason – use them.
- 2.) No Kegs are allowed within units, or on unit/property grounds, for any reason. They are legal on the beach, however.
- 3.) We understand that condos do not have daily maid service, and understand that we will be charged for ruined towels, bedding, and/or furnishings. Do not clean your shoes with towels.
- 4.) We agree that check out time is not later than 9 a.m. CST on Saturday, and that we will drop off all keys at the Inertia Tours office, or agree to total forfeiture of our damage deposits. We agree that lost keys cost \$10.00 per key. Any unpaid balances in groups, and/or returned checks and/or chargebacks and/or late checkout by this group will also result in use of these credit cards for applicable fees. *Late check out is \$250 per condo.*
- 5.) We agree that our property may require a condo security wristband, and that we may be denied access for its removal. Replacement bands are available ONLY with the return of the broken band, at a charge of \$35.00 per band.
- 6.) We agree that we will not attempt to “sneak” additional people into our accommodations, and, that if discovered, we will be immediately evicted without refund.
- 7.) Agree that we will not cause, be involved in, or party to, any physical violence, the threat of, nor the participation in any fighting of any kind, nor its threat. Any roommate found to be involved in fighting will cause eviction of all roommates from unit(s) at no refund.
- 8.) Agree that the legal drinking age in the State of Texas is 21 years of age, and agree not to participate in, nor condone, nor drink, if we are not 21. Open containers are legal only on the beach & within our units, not on the street.
- 9.) Agree that the use of Marijuana, Narcotics, and/or other controlled substances is illegal in the State of Texas.

**We, Agree that eviction from our accommodations, revocation of party package tickets and/or meal tickets can result from any/all of the violation of any house rules listed above.**
